**Newsletter Celebrates Ten Year Anniversary**

**HUNTINGDON VALLEY, Pa.**— This month marks the completion of ten years of publication of the *ISMP Medication Safety Alert! Acute Care edition*, which has grown to become one of the most timely and comprehensive medication alert systems in the world. It is now the only publication reaching nearly every U.S. hospital with vital and potentially life-saving information on medication and device errors and adverse drug reactions as well as practical prevention strategies.

The first issue of the newsletter was sent out on January 15, 1996. It was produced by two staff members and sent by fax to about 30 hospitals. The biweekly newsletter now has a readership of more than 650,000, a dedicated editorial staff of five and dedicated advisory and review committees.

In the first issue, the Institute described its plans for capturing important information communicated to the United States Pharmacopeia (USP)-ISMP Medication Error Reporting Program voluntarily by health care providers and patients, and suggested that subscribers use the information by placing recommendations on an appropriate committee agenda each month and brainstorming prevention measures with department staff.

Over the years, those suggestions have obviously been taken to heart. Many of the nation's hospitals continue to track this information on an ongoing basis, assigning tasks and completion dates to assure problems identified through the USP-ISMP MERP and featured in the newsletter are appropriately addressed.

A 2004 readership survey completed by 748 subscribers provided evidence that the newsletter has spurred numerous changes to reduce the risk of medication errors. Most pharmacy directors (95%), quality/risk management staff (90%), and nurse executives (87%) who responded reported that the newsletter had prompted organization-wide changes. More than 70% of frontline practitioners, such as staff nurses and pharmacists, reported frequent changes in their individual practices in response to newsletter coverage. Many readers reported increased patient and staff education using the newsletter as a learning aid.

It is sent biweekly via e-mail and subscribers also receive urgent advisories about serious errors or information that requires immediate attention. Information can be reproduced and circulated in whole or in part within the subscribing organization.

An anniversary archive CD ROM containing ten years of *ISMP Medication Safety Alert!* is now available. The CD contains all back issues through the end of 2005, including all original text, images, and pertinent links to additional material on ISMP's website.
